<b>Slip – Trip – Fall</b> At the slide entry and exit area	<ul style="list-style-type: none"> <li>• Top and bottom of slide is supervised by trained leader</li> <li>• Participants are briefed on slide safety</li> <li>• Leaders assist the participants as they lay on the mat ready for takeoff</li> <li>• Use the stairs provided when exiting the lake after completing the waterslide</li> <li>• Area to be checked for hazards prior to use</li> </ul>	Unlikely	Minor	Satisfactory
<b>Striking / cuts / abrasions</b> Contact or collisions with other persons, objects or slide surface	<ul style="list-style-type: none"> <li>• Participants must wait until given the all clear from the leader before commencing</li> <li>• Participants must use the safety equipment provided (waterslide mat and helmet)</li> <li>• Participants are briefed regarding the correct use of the waterslide mat and the correct body position when sliding</li> <li>• Group members viewing from the side must not interfere with the sliders</li> <li>• Slide surface is checked regularly as part of the ongoing maintenance schedule</li> </ul>	Unlikely	Minor	Satisfactory

**Risk Rating – Waterslide**

All identified risks are recorded in the Risk Matrix according to the Likelihood and Consequence ratings. The purpose of this matrix is to provide a snapshot of all identified risks and establish the level of risk associated to determine if further treatment is required.

NB: All risks in **bold** are Waterslide specific risks. All other risks are from the General Activity Hazards RMP and are therefore relevant for all activities.

For grading risks, scores obtained from the risk matrix are assigned grades as follows;

HIGH 20 – 80	MEDIUM 10 – 16	LOW 1 – 8
Unacceptable risk which requires immediate action to reduce or remove the hazard. <b>Senior management must be notified.</b> Item should be <b>TAKEN OFF LINE</b> until risk reduced.	Conditionally acceptable, requires short term controls and continuous monitoring.	Acceptable risk, however monitoring required ensuring risk does not escalate. Review in 12 months or if situation changes.
