<ul> <li>All participants must be wearing a PFD that is correctly fitted and in good working order prior to participants getting in the water</li> <li>Caused by;</li> <li>Inability to swim</li> <li>Complacency or overconfidence in own swimming ability</li> <li>Non-swimmers or weak swimmers who are completing the activity are closely monitore at all times</li> <li>Life guards have a lifesaving tube and throw bags on hand at all times</li> <li>No-go zones are highlighted during the briefing (outside the buoys, behind or under the tramp, under the dock)</li> </ul>		Rare	Catastrophic	Satisfactory

For grading risks, scores obtained from the risk matrix are assigned grades as follows;

HIGH	MEDIUM	LOW
20 – 80	10 – 16	1 – 8
Unacceptable risk which requires immediate action to reduce or remove the hazard. Senior management <b>must</b> be notified. Item should be <b>TAKEN OFF LINE</b> until risk reduced.	Conditionally acceptable, requires short term controls and continuous monitoring.	Acceptable risk, however monitoring required ensuring risk does not escalate. Review in 12 months or if situation changes.
